SUBJECT: Integration of the Improved Gap Portions of Zamboanga del Sur Coastal Road and Sindangan-Bayog-Lakewood Road under the Jurisdiction of Zamboanga del Sur 2nd District Engineering Office (DEO), Region IX

In order to maintain the correctness of the Road and Bridge Information Application (RBIA) in accordance with D.O. No. 124, Series of 2016, the improved gap portions of Rebokon-Culasian Section (L = 14.030 km) and Biu-os-Jct Kulot Section (L = 5.623 km) along Zamboanga del Sur Coastal Road (converted into a national road by virtue of Republic Act No. 10550, series of 2013) and Canoayan-Deporehan-Titik Section (L = 5.163 km) of Sindangan-Bayog-Lakewood Road (converted into a national road by virtue of Republic Act No. 10016, series of 2010), are hereby incorporated into the RBIA as part of the aforementioned national road networks, under the jurisdiction of Zamboanga del Sur 2nd District Engineering Office (DEO), Region IX.
