## **RESOLUTION NO. 08-2021**



## APPROVING THE REQUESTS FOR EXTENSION OF VARIOUS PROCURING ENTITIES AND THE EXTENSION OF DEADLINE FOR THE SUBMISSION OF PROCUREMENT REPORTS

**WHEREAS**, Republic Act (RA) No. 9184, otherwise known as the "Government Procurement Reform Act" and the 2016 revised Implementing Rules and Regulations (IRR) took effect on 26 January 2003 and 28 October 2016, respectively;

WHEREAS, Section 63 of RA No. 9184 and its 2016 revised IRR authorizes the Government Procurement Policy Board (GPPB) to formulate public procurement policies, rules and regulations, and amend its IRR, whenever necessary;

**WHEREAS,** the President declared a State of Public Health Emergency due to the coronavirus disease 2019 (COVID-19) under Proclamation No. 922 dated 8 March 2020, and thereafter, a community quarantine over the entire Luzon was imposed which restricted movements and physical operations of the procuring entities (PEs);

WHEREAS, on 20 May 2020, the GPPB issued Circular No. 02-2020 providing guidelines for the submission and posting of Annual Procurement Plans (APPs), Procurement Monitoring Reports (PMRs), and Agency Procurement Compliance and Performance Indicators (APCPI) Results in consideration of the constraints of the PEs in the preparation of the required procurement reports, and resolved to issue the deadlines for submission, as follows;

WHEREAS, the President, through Presidential Spokesperson Harry Roque, declared the imposition of Enhance Community Quarantine (ECQ) over the National Capital Region (NCR), Bulacan, Rizal, Cavite and Laguna from 29 March to 12 April 2021 due to the surge of confirmed COVID-19 cases. The said quarantine imposition was extended but shifted to a Modified ECQ until 14 May 2021;

**WHEREAS**, the GPPB-Technical Support Office (TSO) received various inquiries on, as well as requests for, the extension of the deadline for the submission of subject procurement reports, providing the following justifications, among others:

- 1. Agency imposed lockdown due to confirmed COVID-19 cases which resulted to guarantine of its employees;
- Inaccessibility of procurement documents and/or unavailability of signatories due to work from home arrangement and non-adoption of digital signatures; and
- Difficulty in verifying and confirming procurement data that will be reflected in the reports considering the work from home arrangement of the responsible employee.
