**SUBJECT: Prescribing the Official Newspaper of
the DPWH for Advertisement**

In accordance with Section 21 of the Revised Implementing Rules and Regulations (R-IRR) of Republic Act No. 9184, and in line with the principle of transparency and competitiveness, all Invitations to Bid and Requests for Expression of Interest for contracts under competitive bidding shall be advertised by the Procuring Entity in such manner and for such length of time as may be necessary under the circumstances, in order to ensure the widest possible dissemination thereof, such as, but not limited to, posting in the Procuring Entity's premises, in newspaper of general circulation, the PhilGEPS and the website of the Procuring Entity, if available.

All advertisements of the DPWH - Central Office, for Invitation to Bid and Request for Expression of Interest in the Procurement of Civil Works, Consultancy Services and Goods, shall be advertised only in the hereunder newspaper of general circulation which was selected through public bidding, as per approved BAC Resolution No. G-021-15 dated September 24, 2015. The advertisements shall be published in this official newspaper of the DPWH - Central Office for a period of one (1) year from the date of this Order at the prescribed rate below:

However, Regional and District Engineering Offices may use other national newspapers of general nationwide circulation, provided that the newspaper must be a broadsheet and has been in circulation for the last five (5) years nationwide before the date of issue of the advertisement, with at least 100,000 copies daily circulation and does not exceed Php 38.08/col. cm inclusive of all taxes and charges.

This Order supersedes D.O. No. 178 series of 2015 and shall take effect immediately.
