AMENDING THE AUTHORITIES AND AREAS OF RESPONSIBILITIES OF THE DPWH UNDERSECRETARIES AND ASSISTANT SECRETARIES

In the interest of the service and in view of the appointment of **Engrs. BONIFACIO O. SEGUIT** and **ROY L. MANAO** as DPWH Assistant Secretaries, and as per Minute Resolution No. 10-0513 promulgated by the COMELEC En Banc on 20 April 2010, the authorities and areas of responsibilities of DPWH Undersecretaries and Assistant Secretaries are hereby amended, as follows:

Senior Undersecretary MANUEL M. BONOAN

Shall have overall supervision and management of operations of all Bureaus, Services, Regional Offices, and Project Management Offices. In addition, he shall oversee the overall implementation of priority projects under the "Super Regions". He shall also act as Chairman of the DPWH Management Committee (MANCOM).

Undersecretary ROMEO S. MOMO

Undersecretary RAFAEL C. YABUT

Undersecretary BASHIR D. RASUMAN Shall serve as Undersecretary for Operations for Regions I, II, III, IV-A, the Cordillera Administrative Region (CAR), and the National Capital Region (NCR). He shall act as Chairman of the Central Office Bids and Awards Committee (BAC) for Civil Works in his area of responsibility. The Legislative Liaison Office shall also be under his supervision.

Shall serve as Undersecretary for Operations for Regions IV-B, V, VI, VII, and VIII. He shall act as Chairman of the Central Office Bids and Awards Committee (BAC) for Civil Works in his area of responsibility. In addition, the Road Program Office (RPO) and the Public Information Division (PID) shall be under his supervision.

Shall serve as Undersecretary for Operations for Regions IX, X, XI, XII, and XIII. He shall also act as Chairman of the Central Bids and Awards Committee (BAC) for Civil Works in his area of responsibility. In addition, he shall act as Chairman of the Special BAC for Build-Operate-Transfer (BOT) Projects.

Undersecretary JAIME A. PACANAN Shall serve as Undersecretary for Administration, Finance, Legal and Information Technology. As such, he shall have supervision and control over the Administrative and Manpower Management Service (AMMS), Comptrollership and Financial Management Service (CFMS), Legal Service (LS), and Monitoring and Information Service (MIS). In addition, he shall act as Chairman of the DPWH Grievance Committee.

Assistant Secretary RAUL C. ASIS	Shall serve as Assistant Secretary for Technical Services "A." As such, he shall have supervision and control over the Bureau of Design (BOD) and the Bureau of Research and Standards (BRS). He shall act as Chairman of the Special Bids and Awards Committee (BAC) for NRIMP-2 and the Central Office BAC for Consultancy.
Assistant Secretary DIMAS S. SOGUILON	Shall serve as Assistant Secretary for Technical Services "B." As such, he shall have supervision and control over the Bureau of Construction (BOC) and the Bureau of Maintenance (BOM).
Assistant Secretary MARIA CATALINA E. CABRAL	Shall serve as Assistant Secretary for Planning. As such, she shall have supervision and control over the Planning Service and other planning-related offices. In addition, she shall act as Chairperson of the DPWH Committee on Gender and Development (COGAD).
Assistant Secretary EMIL K. SADAIN	Shall serve as Assistant Secretary for Technical Services "C" and Special Bridges Operations. As such, he shall have supervision and control over the Bureau of Equipment (BOE). He shall also have overall supervision and control of all special foreign- assisted bridge projects and shall remain as the Executive Director of the President's Bridge Program (PBP) Office.
Assistant Secretary BONIFACIO O. SEGUIT	Shall serve as the Assistant Secretary for Administration and Information Technology and Assistant Secretary for Operations for Region IV-A. As such, he shall report directly to the Undersecretary for Administration, Finance, Legal and Information Technology and the Undersecretary for Luzon Operations, on matters concerning the respective areas of jurisdictions of the said Undersecretaries. In addition, he shall act as Chairman of the Central Selection Board (CSB) and the Central Office Bids and Awards Committee (BAC) for Goods.
Assistant Secretary ROY L. MANAO	Shall serve as Assistant Secretary for Finance and Legal Affairs. As such, he shall report directly to the Undersecretary for Administration, Finance, Legal and Information Technology on matters concerning finance and legal affairs. In addition, he shall act as Chairman of the Central Disposal Committee (CDC).

Other special assignments and the supervision and control over major infrastructure programs and Project Management Offices shall be covered by a separate Special Order.

The Internal Audit Service (IAS) shall remain to be placed directly under the Office of the Secretary.

The Assistant Secretaries and the Undersecretaries shall report to the Secretary through the Senior Undersecretary.

This Order amends Department Order No. 38, series of 2009, and all other issuances inconsistent herewith are hereby amended, modified and/or rescinded accordingly.

This Order shall take effect immediately.
