

**AMENDING THE AUTHORITIES AND AREAS OF
RESPONSIBILITIES OF DPWH UNDERSECRETARIES
AND ASSISTANT SECRETARIES**

In the interest of more efficient service and pursuant to Sections 6 and 37 of Executive Order No. 124 dated 30 January 1987, the authorities and areas of responsibilities of Undersecretaries and Assistant Secretaries of this Department as last defined under Department Order No. 169 dated 21 September 2000 are hereby amended as follows:

- Undersecretary TEODORO T. ENCARNACION - is hereby designated as the Undersecretary for Planning and Technical Services. He shall have overall supervision and control of the Planning Service, Management Information Service, Bureau of Construction, Bureau of Design, Legislative Liaison Office and Project Management Offices (PMOs) whose functions specifically pertain to planning, project preparation, engineering and evaluation. Further he shall discharge the duties and responsibilities pertaining to other assignments as may be given by the Secretary from time to time.
- Undersecretary EDMUNDO V. MIR - is hereby designated as the Undersecretary for Maintenance Operations. He shall have overall supervision and control of the Bureau of Maintenance, Bureau of Equipment, Bureau of Research and Standards, Public Information Office, Project Management Offices tasked to implement maintenance-related projects, and the maintenance operations of Regional and District Engineering Offices. Further, he shall discharge the duties and responsibilities pertaining to other assignments as may be given by the Secretary from time to time.
- Undersecretary MABINI F. PABLO - is hereby designated as the Undersecretary for Administrative, Legal and Financial Management Services. He shall have overall supervision and control of the Administrative and Manpower Management Service, Legal Service, Comptrollership and Financial Management Service, and the Procurement Management Office. He shall be assisted by

two Assistant Secretaries — one to have direct supervision over the Legal and Administrative Service and the other to have direct supervision over the Comptrollership and Financial Management Service and the Procurement Management Office. Further, he shall discharge the duties and responsibilities pertaining to other assignments as may be given by the Secretary from time to time.

Undersecretary MANUEL M. BONOAN

- is hereby designated as the Undersecretary for Construction Operations for PMO projects in Luzon and the Visayas with administrative supervision over all Project Management Offices performing construction functions in Luzon, Visayas and Mindanao. Further, he shall discharge the duties and responsibilities pertaining to other assignments as may be given by the Secretary from time to time.

Assistant Secretary JESUS P. CAMMAYO

- is hereby designated as the Assistant Secretary in-charge of construction operations for locally-funded projects in Luzon and the Visayas. Further, he shall discharge the duties and responsibilities pertaining to other assignments as may be given by the Secretary from time to time.

Assistant Secretary BASHIR D. RASUMAN

- is hereby designated as the Assistant Secretary in-charge of construction operations for all locally-funded and PMO-projects in Mindanao. Further, he shall discharge the duties and responsibilities pertaining to other assignments as may be given by the Secretary from time to time.

Assistant Secretary JOSE H. ESPIRITU and Assistant Secretary JOEL L. ALTEA shall continue to perform the same duties and responsibilities as defined under Department Order No. 169, series of 2000, until the same is modified upon retirement of the former.

The Internal Audit Service shall continue to be directly under the Secretary.

The above-mentioned authorities and functions shall be performed by the above-named officials in accordance with the provisions of Department Order No. 42, series of 1988, as amended, as well as with other pertinent issuances.

This Order shall take effect immediately. All other orders, circulars and memoranda, or part(s) thereof inconsistent herewith are hereby revoked and/or modified accordingly.
