AMENDING THE AUTHORITIES AND AREAS OF RESPONSIBILITIES OF THE TWO ASSISTANT REGIONAL DIRECTORS

In the interest of more efficient service and to ensure proper maintenance and preservation of the country's roads and bridges and other related infrastructure facilities, the assignments, duties and responsibilities of the two Assistant Regional Directors of this Department are hereby amended.

There shall be an Assistant Regional Director for Maintenance Operations and an Assistant Regional Director for Construction Operations.

The Assistant Regional Director for Maintenance Operations shall have direct supervision and control over the Maintenance Division, Materials Quality Control and Hydrology Division, Administrative Division and the Regional Equipment Service. He shall oversee the maintenance operations in all District Engineering Offices within the Region and ensure that same are done in accordance with governing rules, regulations and guidelines pertinent thereto and that maintenance projects are implemented in accordance with approved plans and specifications. He shall be the Chairman of the Bidding and Awards Committee (BAC) for civil works projects related to maintenance and the Bidding and Awards Committee (BAC) for the procurement of supplies, materials and equipment.

The Assistant Regional Director for Construction Operations shall have direct supervision and control over the Construction Division, Planning and Design Division and Comptrollership Division. He shall oversee the construction operations in all District Engineering Offices within the Region and ensure that same are done in accordance with governing rules, regulations and guidelines pertinent thereto and that construction projects are implemented in accordance with approved plans and specifications. He shall be the Chairman of the Bidding and Awards Committee (BAC) for civil works projects related to construction.

The following shall be the Assistant Regional Directors for Maintenance Operations and Construction Operations in each of the DPWH's Regional Offices:
