SUBJECT: **AMENDING THE AUTHORITIES AND AREAS OF RESPONSIBILITIES OF THE DPWH UNDERSECRETARIES AND ASSISTANT SECRETARIES**

In the interest of the service and pursuant to the provisions of Executive Order No. 124, series of 1987, and in view of the appointment of Engr. RAUL C. ASIS as DPWH Undersecretary, the authorities and areas of responsibilities of DPWH Undersecretaries and Assistant Secretaries are hereby amended, consistent with the rationalization directions adopted earlier by the Department, as follows:

A. Undersecretaries

The areas of responsibilities of the four (4) DPWH Undersecretaries shall be delineated as follows: 1) Undersecretary for Technical Services, 2) Undersecretary for Support Services, 3) Undersecretary for Regional Operations, and 4) Undersecretary for PMO Operations.

1. The Undersecretary for Technical Services shall have overall supervision and control over the operations of all Bureaus. The Quality Assurance Units shall be directly under his/her overall supervision.
2. The Undersecretary for Support Services shall have overall supervision and control over the operations of the Administrative and Manpower Management Service (AMMS), Comptrollership and Financial Management Service (CFMS), Monitoring and Information Service (MIS), Legal Service (LS), and Central Procurement Office (CPO).
3. The Undersecretary for Regional Operations shall have overall supervision and control over all Regional and District Offices.
4. The Undersecretary for PMO Operations shall have overall supervision and control over all Project Management Offices (PMOs) of the Department.

B. Assistant Secretaries

The areas of responsibilities of the six (6) DPWH Assistant Secretaries shall be delineated as follows: 1) Assistant Secretary for Planning and Public-Private Partnership (PPP), 2) Assistant Secretary for Technical Services, 3) Assistant Secretary for Support Services, 4) Assistant Secretary for Luzon Operations, 5) Assistant Secretary for Visayas and Mindanao (Vis-Min) Operations, and 6) Assistant Secretary for PMO Operations.

1. The Assistant Secretary for Planning and Public-Private Partnership (PPP) shall have overall supervision and control over the Planning Service (soon to be Planning and Project Development Service) and the Public-Private Partnership Service (to be created). He/she shall report directly to the Secretary.
2. The Assistant Secretary for Technical Services shall assist the Undersecretary for Technical Services in the overall supervision and control over the Bureau of Design, Bureau of Construction, Bureau of Maintenance (soon to be Bureau of Road Safety and Maintenance), Bureau of Research and Standards, and the Bureau of Equipment.

3. The Assistant Secretary for Support Services shall assist the Undersecretary for Support Services in the overall supervision and control over the Administrative and Manpower Management Service, Comptrollership and Financial Management Service, Monitoring and Information Service (soon to be Information Management Service), Legal Service, and Central Procurement Office (soon to be Procurement Service).
4. The Assistant Secretary for Luzon Operations shall assist the Undersecretary for Regional Operations in the overall supervision and control over all Regional and District Offices in Luzon (i.e., Regions I, II, III, IV-A, IV-B, V, CAR and NCR).
5. The Assistant Secretary for Visayas and Mindanao (Vis-Min) Operations shall assist the Undersecretary for Regional Operations in the overall supervision and control over all Regional and District Offices in Visayas and Mindanao (i.e., Regions VI, VII, VIII, IX, X, XI, XII and XIII).
6. The Assistant Secretary for PMO Operations shall assist the Undersecretary for PMO Operations in the overall supervision and control over all Project Management Offices.

Pending the appointment of the Assistant Secretary for Support Services, the Undersecretary for Support Services shall exercise for the meantime direct supervision and control over the AMMS, CFMS, MIS, LS and CPO.

The Internal Audit Service and the External Stakeholders Relations Office (to be created) shall be under the direct supervision and control of the Office of the Secretary.

All other designations and ad hoc assignments previously given to the DPWH Undersecretaries and Assistant Secretaries by the Secretary under various issuances which are not inconsistent herewith shall remain in effect until revoked, amended, modified and/or rescinded accordingly.

This Order takes effect immediately.
