<u>Classification</u>	<u>Limits of Assignment</u>
Materials Engineer II	<ul style="list-style-type: none">- One (1) project, no cost limit- Two (2) projects located within the same province for simultaneous assignments, with an aggregate cost of not more than P150M.
Materials Engineer I	<ul style="list-style-type: none">- One (1) project costing below P150M.- Four (4) projects located within the same province for simultaneous assignments, with an aggregate cost of not more than P50M.

A Certificate of Accreditation and an Identification Card bearing a Permanent Accreditation Number shall be issued to each accredited engineer.
