DEPARTMENT ORDER ) SUBJECT: **OPERATIONALIZATION OF THE ALBAY**  
No. 61 ) **FIRST DISTRICT ENGINEERING OFFICE,**  
Series of 2010 *NRBA 11-04-10* ) **DPWH REGION V**

Pursuant to the provisions of Republic Act No. 9693, dated 04 August 2009, establishing the Albay First (1<sup>st</sup>) District Engineering Office (DEO) in the Province of Albay, the said DEO is hereby operationalized under the DPWH Region V. Its headquarters shall be located in Tabaco City.

The Albay 1<sup>st</sup> DEO shall comprise the City of Tabaco and the municipalities of Tiwi, Malinao, Malilipot, Bacacay and Sto. Domingo. The existing district engineering office located in Legaspi City shall be known as the Albay 2<sup>nd</sup> DEO and shall comprise the City of Legaspi and the municipalities of Rapu-Rapu, Manito, Camalig and Daraga. The Albay 3<sup>rd</sup> DEO located in Polangui shall comprise the City of Ligao and the municipalities of Guinobatan, Jovellar, Pio Duran, Oas, Polangui and Libon.

Pending approval of the DPWH Rationalization Plan, the Albay 1<sup>st</sup> DEO shall be constituted and manned by appropriate personnel from the Regional Office and/or other offices of the Department as may be identified by the Regional Director of DPWH Region V, subject to approval by appropriate official of the Department, CS Law and Rules and pertinent provisions of the Omnibus Election Code. The DPWH Central Office may also provide technical and planning support to the Albay 1<sup>st</sup> DEO as may be necessary.

The initial cost to operationalize the Albay 1<sup>st</sup> DEO shall be charged against appropriate funds of the Department, subject to existing accounting and auditing rules and regulations. Succeeding funding requirements shall be included in the annual budget of the Department.

Supplementary directives may be issued by the Regional Director of DPWH Region V to implement this Order, furnishing the Office of the Secretary with copies thereof.

This Order supersedes previous issuances to the contrary and shall take effect immediately.

[ REPUBLIC ACT NO. 9693 ]

AN ACT RECONSTITUTING THE ALBAY ENGINEERING DISTRICT OFFICES IN THE PROVINCE OF ALBAY INTO THREE (3) REGULAR DISTRICT ENGINEERING OFFICES AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

SECTION 1. The Albay District Engineering Offices, under the supervision of the Department of Public Works and Highways, shall be reconstituted into three (3) separate district engineering offices to be respectively named as follows: (1) Albay First District Engineering Office; (2) Albay Second District Engineering Office; and (3) Albay Third District Engineering Office.

SEC. 2. The Albay First District Engineering Office to be located in Tabaco City shall comprise the City of Tabaco and the municipalities of Tiwi, Malinao, Malilipot, Bacacay and Sto. Domingo. The existing district engineering office located in Legaspi City shall be known as the Albay Second District Engineering Office and shall comprise the City of Legaspi and the municipalities of Rapu-Rapu, Manito, Camalig and Daraga.


The Albay Third District Engineering Office located in Polangui shall comprise the City of Ligao and the municipalities of Guinobatan, Jovellar, Pio Duran, Oas, Polangui and Libon.


SEC. 3. The Secretary of Public Works and Highways shall include in the Department's program the operationalization of these three (3) district engineering offices, the funding of which shall be included in the annual General Appropriations Act.

SEC. 4. The relevant provisions of Sections 1 and 2 of Republic Act No. 9220 are hereby modified or amended accordingly.


SEC. 5. This Act shall take effect upon its approval.
