

SUBJECT: Declaring Gamu-Roxas Provincial Road
to National Secondary Road in Isabela

Pursuant to the provisions of Executive Order No. 113, series of 1955, as amended and Executive Order No. 459, series of 1975, the Gamu-Roxas, km. 395.109 to km. 423.472, or a net length of 28.363 kms. in Isabela (1st Engineering District) is hereby declared as national secondary road, provided that the 20 meters minimum road right-of-way for titled lands, 60 meters for unpatented public lands and 120 meters for land in forested areas are acquired.


