<u>Classification</u>	<u>Limits of Assignment</u>
Materials Engineer II	<ul style="list-style-type: none"><li>- One (1) project, no cost limit</li><li>- Two (2) projects located within the same province for simultaneous assignments, with an aggregate cost of not more than P150M.</li></ul>
Materials Engineer I	<ul style="list-style-type: none"><li>- One (1) project costing below P150M.</li><li>- Four (4) projects located within the same province for simultaneous assignments, with an aggregate cost of not more than P50M.</li></ul>

A Certificate of Accreditation and an Identification Card bearing a Permanent Accreditation Number shall be issued to each accredited engineer.
