SUBJECT: AMENDING THE AUTHORITIES AND AREAS  
OF RESPONSIBILITIES OF DPWH  
UNDERSECRETARIES AND ASSISTANT  
SECRETARIES.

In the interest of the service and pursuant to Sections 6 and 37 of Executive Order No. 124 dated 30 January 1987, the authorities and areas of responsibilities of Undersecretaries and Assistant Secretaries are hereby amended as follows:

Undersecretary EDMUNDO V. MIR - shall have supervision and control over the Bureau of Construction, Bureau of Maintenance, Bureau of Equipment, and such other special projects as may be assigned by the Secretary.

Undersecretary TEODORO T. ENCARNACION - shall have supervision and control over the Planning Service, Monitoring and Information Service, Bureau of Design, and Bureau of Research and Standards.

Undersecretary MANUEL M. BONOAN - shall have supervision and control over field operations covering all infrastructure projects, including foreign assisted projects in Regions VI, VII, VIII, IX, X, XI, XII and XIII; and shall also act as Chairman of the PBAC and the PEAC for projects within his area of responsibility.

Assistant Secretary JESUS P. CAMMAYO - shall, in addition to his present assignment, as Assistant Secretary for Planning and Monitoring and Information, have supervision and control over field operations covering all infrastructure projects, including foreign assisted projects in Regions I, II, III and Cordillera Administrative Region; and shall also act as Chairman of the PBAC and the PEAC for projects within his area of responsibility.

Assistant Secretary JOSE H. ESPIRITU - shall, in addition to his present assignment as Assistant Secretary for Administrative and Manpower Management, have supervision and control over DPWH infrastructure projects, including foreign-assisted projects, in Regions IV-A, IV-B, V and National Capital Region; and shall also act as Chairman of the PBAC and the PEAC for projects within his area of responsibility.

The above-mentioned authorities and functions shall be performed in accordance with the provisions of Department Order No. 42, series of 1988, as amended, and other pertinent issuances.

The other Undersecretary, Assistant Secretaries, and Officials of the DPWH shall continue to perform their assigned duties and responsibilities in accordance with existing Department issuances.

This Order shall take effect immediately, and all other orders, circulars, and memoranda inconsistent herewith are hereby modified and/or revoked accordingly.
