DEPARTMENT ORDER

SUBJECT: ASSIGNMENT AND COMPOSITION
OF THE BIDS AND AWARDS
COMMITTEE (BAC) FOR CIVIL
WORKS PROJECTS

In the interest of the service and pursuant to the provisions of Republic Act No. 9184, the Government Procurement Reform Act, and consonant with the new authorities and areas of responsibilities of the Undersecretaries and Assistant Secretaries per Department Order No. 79, series of 2003, a new assignment and composition Central Office Bids and Awards Committee (BAC) for Civil Works Projects is hereby made as follows:

The functions of the BAC shall be in accordance with the relevant provisions of R.A. No. 9184 and its Implementing Rules and Regulations (IRR). It shall also continue the unfinished business of the erstwhile BACs using applicable procurement guidelines.

(continuation of D.O. No. 93, s. 2003)

The regular members of the BAC shall have a fixed term of one (1) year reckoned from the date of appointment, renewable at the discretion of the Secretary. In cases of resignation, retirement, separation, transfer, re-assignment, removal, or death, the replacement shall serve only the unexpired term.

The members of the BAC shall give utmost priority to BAC assignments and shall personally attend to all meetings and activities of the Committee unless otherwise directed by the Chairman.


Pursuant to the relevant provisions of R.A. 9184 and its IRR, the following shall be invited as observers, who shall sit in and monitor proceedings of the BAC as non-voting members,

- (e) One (1) Representative from the Commission on Audit (COA)
- (f) One (1) Representative from the Philippine Constructors Association (PCA) or the National Constructors Association of the Philippines (NACAP) or an association recognized by the Construction Industry Association of the Philippines (CIAP)
- (g) The DPWH Resident Ombudsman, per earlier proposal approved by the Secretary.
- (h) One (1) Representative from an end-user group or a non-government organization (NGO).

The BAC shall be assisted by the existing Secretariat that shall have the functions and responsibilities prescribed in R.A. No. 9184 and its IRR and perform other such functions as may be directed by the Chairman. The Secretariat shall also act as the Technical Working Group of the BAC. The head of the Secretariat shall sit as a non-voting member of the BAC.

Any and all existing Department Orders and other issuances inconsistent herewith are hereby repealed accordingly.

This Order takes effect immediately.
