Materials Engineer II	<ul style="list-style-type: none"> - One project, no cost limit or - Two projects located within the same province with - an aggregate cost of not more than P100 M.
Materials Engineer I	<ul style="list-style-type: none"> - One project costing not more than P100 M or - Three projects located within the same province with an aggregate cost of not more than P20 M.

A Certificate of Accreditation and an Identification Card bearing a Permanent Accreditation Number shall be issued to each accredited engineer.
