Revised Selection Criteria On The Filling Of Engineer Positions In the DPWH.

For a broader and more realistic evaluation of candidates for promotion to vacant engineer positions in this Department, the rating obtained by the examinees, in specialized promotional examination given jointly by the Civil Service Commission and the Department of Public Works and Highways to DPWH engineers of various ranks on 05 November 1994 are hereby made part of the selection factors for promotion to vacant positions of Engineer IV, Engineer V, District Engineer, Regional Equipment Engineer, Assistant Regional Director, Project Manager, and Regional Director.

Accordingly, the following modified factors/criteria and their corresponding points and weights in the evaluation and rating of candidates for promotion to the above-mentioned engineer positions are hereby prescribed:
