In the interest of the service and pursuant to the provisions of Republic Act No. 9184 or the Government Procurement Reform Act, and the Implementing Rules and Regulations (IRR) of Executive Order (EO) No. 40, series of 2001, until such time the IRR of R.A. 9184 is approved, and consonant with the new authorities and areas of responsibilities of the Undersecretaries and Assistant Secretaries per Department Order 114, series of 2003, a new assignment and composition of the Central Office Bids and Awards Committee (BAC) for Consultancy is hereby made as follows:

The functions of the BAC for Consultancy shall be in accordance with the relevant provisions of Republic Act 9184. It shall continue the unfinished business of the erstwhile PEAC for Consultancy using applicable procurement guidelines.

The regular members of the BAC for Consultancy shall have a fixed term of one (1) year reckoned from the date of appointment, renewable at the discretion of the Secretary. In cases of resignation, retirement, separation, transfer, re-assignment, removal, or death, the replacement shall serve only the unexpired term.

The following shall be invited as observers, who shall sit in and monitor proceedings of the BAC for Consultancy as non-voting members:

- (a) One (1) Representative from the Commission on Audit (COA);
- (b) One (1) Representative from the Confederation of Filipino Consulting Organization (COFILCO)
- (c) One (1) Representative from a non-governmental organization (NGO).

The BAC for Consultancy shall be assisted by the existing Secretariat that shall have the functions and responsibilities prescribed in R.A. No. 9184 and the IRR of EO 40 and perform other such functions as may be directed by the Chairman. The head of the Secretariat shall sit as a non-voting member of the BAC for Consultancy.

Any and all existing Department Orders and other issuances inconsistent herewith are hereby repealed accordingly.

This order takes effect immediately.
