SUBJECT: NEW DELINEATION OF AUTHORITIES AND AREAS  
OF RESPONSIBILITIES OF UNDERSECRETARIES

For a more effective and efficient operation of the Department, and to accelerate the attainment of its objectives, the following authorities and areas of responsibilities of the Undersecretaries of this Department are hereby delineated:

I. - UNDERSECRETARY TEODORO T. ENCARNACION

1. Undersecretary for Technical Support Services, with administrative and technical supervision over the Planning Service, Bureau of Design, Bureau of Construction, Bureau of Maintenance, Bureau of Equipment, and Bureau of Research and Standards.
2. Chairman, Central Office Prequalification, Evaluation and Awards Committee for consultancy services for feasibility studies and planning activities.

II. - UNDERSECRETARY EDMUNDO V. MIR

1. Undersecretary for field operations in Luzon (Regions CAR, I, II, III, IV-A, IV-B, V and NCR, including Mt. Pinatubo Rehabilitation Projects and Earthquake Rehabilitation Projects) with administrative and technical supervision over all Project Management Offices with projects in Luzon.
2. Chairman, Central Office Prequalification, Bidding and Awards Committee for civil works contracts for projects in Luzon.
3. Chairman, Prequalification, Evaluation and Awards Committee for consultancy services involving engineering and construction supervision of infrastructure projects in Luzon; Co-Chairman of the same Committee for projects affecting Visayas and Mindanao.
4. Chairman, Prequalification, Bidding and Awards Committee for construction equipment, materials and supplies for infrastructure projects in Luzon.

**III. - UNDERSECRETARY WILFREDO P. VALENCIA**

1. Undersecretary for field operation in Visayas and Mindanao (Regions VI, VII, VIII, IX, X, XI AND XII) with administrative and technical supervision over all Project Management Offices with projects in Visayas and Mindanao.
2. Chairman, Central Office Prequalification, Bidding and Awards Committee for civil works contracts for projects in Visayas and Mindanao.
3. Chairman, Prequalification, Evaluation and Awards Committee for consultancy services for engineering design and construction supervision of infrastructure projects in Visayas and Mindanao; Co-Chairman for the same Committee for projects affecting Luzon.
4. Chairman, Prequalification, Bidding and Awards Committee for construction equipment, materials and supplies for infrastructure projects in Visayas and Mindanao.

**IV. - UNDERSECRETARY GREGORIO S. ALVAREZ**

1. Undersecretary for Administrative and Financial Support Services, with administrative and technical supervision over the Administrative and Manpower Management Service, Comptrollership and Financial Management Service, Legal Service, Internal Audit Service and Monitoring and Information Service except the Public Information Division which will report directly to the Office of the Secretary.
2. Chairman, Central Office Prequalification, Bidding and Awards Committee for office equipment, materials and supplies.

The above-named Undersecretaries shall discharge their respective functions in accordance with the provision of Department Order No. 55 s. of 1991, and other pertinent issuances. All Department Orders inconsistent herewith are revoked/amended accordingly.

This Department Order supersedes D.O. No. 142 s. of 1993 dated June 16, 1993, and shall take effect immediately.
