

The Technical Working Groups will assist in enhancing the skills of the DPWH staff required for the full implementation of the revised planning process under the National Road Improvement and Management Program (NRIMP).

In order to attain effective implementation of the planning activities, the Road Network Administrator / Assistant Supervisor and the Road Network Administrator Assistant of the LRS Administration group together with the GIS Coordinator of the Interim GIS group shall report to the RIMSS office regularly (at least 50% of their time) to work with the Consultants for the transfer of knowledge. The other members of the groups shall report to the RIMSS office to do their assigned tasks on call basis.
