The technical staff/secretariat shall be composed of personnel presently detailed to the NBCDO and to be supplemented by personnel from the BOD, BOC, BRS, Legal Service and PMO-Special Buildings. The NBCDO Acting Executive Director shall issue a directive to the assigned personnel.

The BOC shall undertake the following continuing and proposed activities:

1. Preparation of the Handbook on the Enforcement and Implementation of the NBC 9PD 1096) and Its Revised IRR;
2. Study on the Proposed Amendments to the NBC (PD 1096);
3. Nationwide information dissemination/campaign of the Revised IRR of the NBC.

All expenses to be incurred in these activities and the honoraria/allowance of the personnel involved shall be charged against any available funds of the Department, subject to the usual accounting and auditing rules and regulations.

This Order supersedes previous issuances to the contrary and shall take effect until the completion of the aforesaid activities.
