**DESIGNATION OF ASSISTANT SECRETARY
JUANITO P. ABERGAS AS IN-CHARGE OF THE
IMPLEMENTATION OF ALL FARM-TO-
MARKET ROAD (FMR) PROJECTS, EXCEPT
THOSE UNDER D.O. NO. 65, SERIES OF 2005**

In the interest of the service and pursuant to Sections 6 and 7 of Executive Order No. 124 dated 30 January 1987, Assistant Secretary **JUANITO P. ABERGAS** is hereby designated, in addition to his present duties and responsibilities, as In-Charge of the implementation of all Farm-to-Market Road (FMR) projects, except those under D.O. No. 65, series of 2005.

Under and by virtue of this Order, Assistant Secretary Abergas shall exercise direct supervision and control over all pre-implementation and implementation-related activities, including post-implementation performance evaluation of all FMR projects. He shall report directly to Undersecretary Manuel M. Bonoan.

This Order supersedes previous issuances to the contrary and shall take effect immediately.

DEPARTMENT ORDER 65 Series of 2005 <i>06.09-05</i>))))	AMENDING THE AUTHORITIES AND AREAS OF RESPONSIBILITIES OF DPWH UNDERSECRETARIES AND ASSISTANT SECRETARIES
---	------------------	--

In the interest of the Service, the authorities and areas of responsibilities of Undersecretaries and Assistant Secretaries are hereby amended, as follows:

USEC MANUEL M BONOAN – Shall have overall supervision and control of the operations of all Regions and all Project Management Offices (PMOs) except PMOs performing planning related functions and PMOs implementing special projects funded by other government agencies. He shall likewise be the Chairman of the Central Office Bids and Awards Committee (BAC) for all civil works.

USEC BASHIR D. RASUMAN – Shall have overall supervision and control of the Administrative and Manpower Management Service, Comptrollership and Finance Management Service and Legal Service.

USEC FLORANTE SORIQUEZ– Shall have overall supervision and control of PMOs implementing special projects of the Department funded by other government agencies such as Department of Education, Department of Land Reform, and other government agencies. He shall likewise serve as the Chairman of the Central Office BAC for Consultancy.

USEC SALVADOR A. PLEYTO – Shall have overall supervision and control of the Bureau of Design, Bureau of Construction, Bureau of Equipment and Bureau of Maintenance.

USEC ANTONIO A. INOCENTES – Shall have overall supervision and control of the Road Program Office.

ASEC MANUEL S. AGYAO – Shall serve as Assistant Secretary of AMMS and CFMS to assist Usec Rasuman.

ASEC RAUL C. ASIS – Shall have overall supervision and control of the Planning Service, Monitoring and Information Service (MIS), Bureau of Research and Standards and all PMOs performing planning related functions. He shall be reporting directly to the Secretary.

ASEC RAFAEL C. YABUT – Shall serve as Assistant Secretary for operations to assist Usec Bonoan. He shall also serve as the Department's Legislative Liaison Officer.

This Order shall take effect immediately. All other orders, circulars, memoranda and issuances inconsistent herewith are hereby amended, modified and/or rescinded accordingly.
