**CREATION OF A COORDINATING

The tasks of the Bantay Lansangan Coordinating Committee shall include but not be limited to the following:

To ensure the effective and coordinated implementation of the activities of Bantay Lansangan, Inc., a road sector partnership group created to work with the DPWH to ensure transparency, accountability, efficiency and high quality of services within the road sector, a **Bantay Lansangan Coordinating Committee** is hereby created to be composed of the following:

The tasks of the Bantay Lansangan Coordinating Committee shall include but not be limited to the following:

1. Active participation in the activities of Bantay Lansangan, Inc., specifically in the provision of support to the associations's areas of engagement, such as monitoring and analysis of all phases of delivery of public services, including planning, design, fund allocation and utilization, procurement, construction and maintenance; communication of information on national road service; advocacy on greater public awareness and transparency in the national road sector; and training of stakeholders in basic processes and in monitoring of national road services.
2. Efficient management of information to be provided by DPWH to the road partnership group in pursuance of its activities, by establishing acceptable policy and business processes related to the screening and accreditation of Bantay Lansangan volunteers, and disclosure of relevant information and data on the performance of the national road sector, as specified in the Constitution and By-Laws of Bantay Lansangan, Inc. and in conformity with generally accepted public disclosure principles.
3. Ensure that prompt actions are taken on reports of Bantay Lansangan, Inc. on defective, inadequate, insufficient or irregular aspects in the delivery of national road services, and provide immediate feedback thereon to the latter.

This Order shall take effect immediately.
