

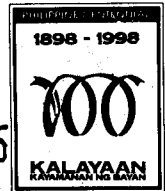

Per Memorandum of Agreement between DBM, DepED, DSWD, DOH and DPWH, the World Bank, thru its Second Social Expenditure Management Project (SEMP 2) will provide budgetary support on basic social services such as education, primarily on the construction of the school buildings under the CY 2004 DepED School Building Program. To facilitate World Bank requirements on procurement, the above-cited committee is being created and its functions must be in accordance with the procedures and schedules agreed upon on the SEMP 2 implementation.

The SB-BAC is hereby authorized to designate its own secretariat and TWG and to call upon any office of this Department including the Central-BAC Secretariat/TWG for any assistance in the procurement process of schoolbuilding projects.

The following shall be invited as observers, who shall sit in and monitor proceedings of the BAC:

- (a) One (1) Representative from the Commission on Audit (COA)
- (b) One (1) Representative from the Philippine Constructors Association (PCA) or The National Constructors Association of the Philippines (NACAP), Philippine Institute of Civil Engineers (PICE) or an association recognized by the Construction Industry Association of the Philippines (CIAP)
- (c) One (1) Representative from the Department of Education
- (d) One (1) Representative which shall come from a Non-Government Organization (NGO)

Any and all existing Department Orders and other issuance inconsistent herewith are hereby repeated accordingly.

This Order takes effect immediately.
