The DPWH Validation Team shall conduct random validation/verification of the QAU findings/observations for not more than five (5) days on the on-going and completed projects implemented by the Regional, District and Project Management Offices (PMOs) not later than five (5) days from receipt of QAU Assessment Reports.

The Validation Team shall be directly reporting to the Office of the Secretary thru the QAU Steering Committee composed of the Assistant Secretary in charge of the BRS as Chairman and the Directors of the BRS, BOD and BOC as members.
