In compliance with the instruction of Her Excellency, President Gloria Macapagal-Arroyo, for the DPWH to act as the Principal Researcher/Investigator of the government on flood management and the lead agency of the government's National Flood Management Committee (NPMC), a DPWH Technical Working Group (TWG) for the formulation of a National Flood Management Framework Plan (NFMFP) is hereby created with the following composition:

The TWG shall perform the following tasks and functions:

1. Collate and consolidate plans and programs, study reports, and other relevant data and information from the NPMC member-agencies;
2. Provide technical support to the NPMC Secretariat;
3. Convene meetings and workshops for the formulation/finalization of the NFMFP;
4. Prepare status reports on the formulation of the NFMFP; and,
5. Prepare the proposed NFMFP based on the comments and recommendations of member-agencies, acting as research assistants.

The TWG may engage the assistance and support of the member-agencies of the NPMC and the organic units of the DPWH to effectively carry out its tasks.

The resident JICA Expert for River Administration and the Chief Advisor for the Project for Strengthening the Flood Management Function of the DPWH shall be Honorary Members of the TWG to provide technical assistance and guidance.

This Order takes effect immediately.
