**SUBJECT: RECONSTITUTION OF THE BOARD OF
CONSULTANTS OF THE NATIONAL
BUILDING CODE OF THE PHILIPPINES**

Considering that most of its previously assigned tasks/activities have already been completed, the Board of Consultants (BoC) of the NBCP which was reconstituted under various Special Orders including Special Order No. 100, series of 2006, and the Oversight Committee which was reactivated under Special Order No. 101, series of 2006, are hereby dissolved to give way for the reconstitution of a new set of Board of Consultants, as follows:

The BoC-NBCP members shall be composed of the representatives of the following agencies and organizations:

Philippine Association of Building Officials (PABO)
Philippine Institute of Civil Engineers (PICE)
Philippine Institute of Environmental Planners (PIEP)
Philippine Institute of Volcanology and Seismology (PHIVOLCS)
Philippine Society of Mechanical Engineers (PSME)
Philippine Society of Sanitary Engineers (PSSE)
Philippine Society of Agricultural Engineers (PSAE)
United Architects of the Philippines (UAP)

The National Building Code Review Committee (NBCRC) which was reconstituted under Special Order No. 101, series of 2006, shall continue to act as the Review Committee of the NBCP pending the reconstitution of a new set of members.

The BoC-NBCP shall undertake the following continuing activities in coordination with the DPWH National Building Code Development Office (NBCDO).

1. Review of the National Building Code of the Philippines per PD 1096 and recommendation of amendments thereof;
2. Study of Proposed Amendments to the NBC (PD 1096), including its Implementing Rules and Regulations (IRR), submitted by various sectors and provision of technical expertise to Congress in aid of legislation;
3. Conduct of seminars and workshops on the National Building Code and its Implementing Rules and Regulations;
4. Review of the existing National Building Code Circulars and other related issuances of the Department and recommendation of appropriate amendment thereof; and,
5. Assistance in the evaluation of National Building Code cases and inquiries.

All expenses to be incurred in these activities and the honoraria/allowances of the personnel involved shall be charged against any appropriate funds of the Department, subject to the usual accounting and auditing rules and regulations.

This Order supersedes previous issuances inconsistent herewith and takes effect immediately.
