INDICATOR FRAMEWORK (OPIF) OF THE
DEPARTMENT

In line with government's objective to ensure effective, coordinated and sustainable implementation of the OPIF which is a results based budgeting framework to make results count in budget decisions, agency and individual performance currently being institutionalized by the Department of Budget and Management in all government agencies, the composition of the PPMC created under Dept. Order No. 30 Series of 2007 is hereby reconstituted as follows:

2. Recalibration of DPWH Programs/Activities/Projects (PAPs) to align with OPIF.
3. Initiate the cascading of OPIF down to the operating units (OUs).
