To strengthen the promotion of *Bagong Pilipinas* as the Administration's brand of governance and leadership, all departments, agencies and instrumentalities of the National Government, including GOCCs, GFIs and SUCs, are hereby directed to use the Bagong Pilipinas logo only in public communications involving positive news, programs and projects of the Administration.

All heads of agencies are also directed to inform their respective bureaus and offices in charge of public information or communication, to comply with this Memorandum. These bureaus and offices must closely coordinate with the PCO relative to the use of the Bagong Pilipinas logo.

As may be necessary, the PCO shall issue the appropriate guidelines for the effective implementation of this directive.
