# APPROVING THE INCLUSION OF NEW TRAINERS INTO THE LIST OF RECOGNIZED TRAINERS OF THE GOVERNMENT PROCUREMENT POLICY BOARD AND AUTHORIZING ITS TECHNICAL SUPPORT OFFICE TO UPDATE AND MAINTAIN THE SAID LIST ON THE GPPB WEBSITE

**WHEREAS**, Republic Act (RA) No. 9184, otherwise known as the "Government Procurement Reform Act", took effect on 26 January 2003, while its 2016 revised Implementing Rules and Regulations (IRR) took effect on 28 October 2016;

**WHEREAS,** RA No. 9184 mandates the Government Procurement Policy Board (GPPB) to establish and maintain a sustained training program to professionalize and develop the capacity of the Bids and Awards Committee (BAC) and its Secretariat and Technical Working Group (TWG) of Procuring Entities (PEs). Similarly, under Section 16 of the Implementing Rules and Regulations (IRR) of RA No. 9184 mandates the Head of the Procuring Entity (HoPE) to ensure that the BAC, its Secretariat, and the TWG satisfactorily complete procurement training or capacity development programs within six (6) months of their designation;

**WHEREAS,** Section 63 of RA No. 9184 and Section 63.1(e) of the 2016 revised IRR of the same law authorize the GPPB to ensure that the PEs regularly conduct training programs related to government procurement, among others;

**WHEREAS,** in accordance with the foregoing, the GPPB, through its Resolution No. 12-2018,<sup>2</sup> approved the issuance of Circular No. 07-2018<sup>3</sup> which provides the requirements to recognize procurement training or capacity development activities for the BAC and its Secretariat, TWG, and the Procurement Units of PEs. Additionally, it authorized the GPPB-Technical Support Office (TSO) to maintain a pool of Recognized Trainers to conduct such activities nationwide. To qualify as GPPB Recognized Trainers, candidates must successfully complete the Recruitment, Selection, Recognition, and Retention Program<sup>4</sup> administered by the GPPB-TSO, followed by a confirmation or recognition by the Board;

WHEREAS, to ensure that the GPPB Recognized Trainers remain updated on the most recent issuances related to the 2016 revised IRR of RA No. 9184 and are highly skilled in presenting and facilitating procurement trainings and workshops, they are required to participate in the regular Knowledge and Skills Enhancement Training

Workshop, a retooling program being conducted by the Capacity Development Division of the GPPB-TSO:<sup>5</sup>

**WHEREAS,** from 2019 to 2021, the GPPB-TSO observed a significant increase<sup>6</sup> in training demand, receiving approximately two hundred (200) training requests annually from various PEs, highlighting the need to fulfill the training requirements of PEs. To meet this demand, the GPPB issued Resolution Nos. 01-2020<sup>7</sup> and 19-2021,<sup>8</sup> which confirmed the List of Recognized Trainers, comprising one hundred seventeen (117) GPPB Recognized Trainers<sup>9</sup> in 2020 and forty-five (45) GPPB Recognized Trainers<sup>10</sup> in 2021,<sup>11</sup> respectively;

**WHEREAS,** accordingly, each trainers, after completing their retooling program, likewise signed a Memorandum of Understanding (MOU) that indicated the specific obligations <sup>12</sup> and formalized their commitment as GPPB Recognized Trainers through an agreement with the GPPB; <sup>13</sup>

**WHEREAS,** continuing this effort, the GPPB-TSO implemented the Recruitment, Selection, and Recognition Program for interested applicants from 31 July 2023 to 25 March 2024, in accordance with GPPB Circular No. 07-2018. The program ensured an efficient evaluation and recognition of candidates based on comprehensive criteria;

**WHEREAS,** as of 29 April 2024, there are eighteen (18) candidates<sup>14</sup> who have qualified to become GPPB Recognized Trainers and signified their commitment to fulfill the obligations outlined in the MOU. These trainers were selected<sup>15</sup> based on a thorough evaluation of their examination scores and their performance in facilitating in-house training sessions;

WHEREAS, to ensure transparency and provide information to relevant stakeholders and the public, the GPPB-TSO maintains a List of GPPB Recognized

Trainers that is posted on the GPPB Website.<sup>16</sup> This List requires regular updating to include the newly recognized trainers and retain existing GPPB Recognized Trainers who have maintained their compliance with the requirements in the signed MOU, which includes the completion of the regular retooling program and the conduct of prescribed number of training sessions;

**WHEREAS**, it bears emphasis that the aforesaid List signifies the active status of existing GPPB Recognized Trainers, given their sustained compliance with the terms and conditions of the MOU. Consequently, this process offers an opportunity for GPPB Recognized Trainers to be retained or reinstated on the List, as the case may be, upon fulfilling the prescribed requirements under the MOU;

**WHEREAS**, on 07 June 2024, during the 2<sup>nd</sup> GPPB Meeting, the GPPB-TSO presented the following recommendations to the Board:

- Include in the List of GPPB Recognized Trainers the eighteen (18) candidates who successfully completed the recent Recruitment, Selection, and Recognition Program. This requires the GPPB's confirmation to include these newly qualified candidates in the updated List of GPPB Recognized Trainers, given that they underwent the Recruitment, Selection, and Recognition Program and signified their commitment to fulfill their obligations under the MOU;
- 2. Authorize the GPPB-TSO to update the List of GPPB Recognized Trainers on the GPPB Website based on validation of compliance by the GPPB Recognized Trainers with the requirements under the MOU. This would help the GPPB-TSO to effectively implement the terms and conditions of the MOU and ensure that the List is updated promptly, without the need for repeated Board approvals. It is emphasized that the updating is subject to the compliance of GPPB Recognized Trainers with the requirements under the MOU, such as regular participation in retooling programs and conduct of the prescribed minimum number of training sessions. Currently, there are approximately one hundred sixty (160) active GPPB Recognized Trainers<sup>17</sup> who should remain compliant with the requirements in order to maintain their status; and
- 3. Require the GPPB-TSO to maintain an updated List of GPPB Recognized Trainers on the GPPB Website, to include GPPB-approved new trainers as well as existing trainers who have completed the regular retooling program and maintained their compliance with the requirements in the signed MOU;

**WHEREAS**, in addition to the foregoing, the representative from the Department of Science and Technology proposed that the GPPB-TSO should submit a report to the GPPB to apprise them of the updated List of GPPB Recognized Trainers;

**WHEREAS**, in consideration of the foregoing, the GPPB, upon recommendation of its TSO and members, resolved to approve the following:

- 1. INCLUDE in the List of GPPB Recognized Trainers the eighteen (18) candidates who successfully completed the recent Recruitment, Selection, and Recognition Program, attached herein as Annex "A";
- 2. AUTHORIZE the GPPB-TSO to update the List of GPPB Recognized Trainers on the GPPB Website based on validation of compliance by the GPPB Recognized Trainers with the requirements in the MOU; and
- 3. REQUIRE the GPPB-TSO to continue to maintain an updated List of GPPB Recognized Trainers on the GPPB Website, to include GPPB-approved new trainers as well as existing trainers who have completed the regular retooling program and maintained their compliance with the requirements in the signed MOU. Additionally, the GPPB-TSO shall submit a report to the GPPB to apprise them on the updated List of GPPB Recognized Trainers.

**NOW, THEREFORE,** for and in consideration of the foregoing, **WE**, the Members of the **GOVERNMENT PROCUREMENT POLICY BOARD**, by virtue of the powers vested on **US** by law and other executive issuances, hereby **RESOLVE** to confirm, adopt, and approve, as **WE** hereby confirm, adopt, and approve the following:

- 1. **INCLUDE** in the List of GPPB Recognized Trainers the eighteen (18) additional individuals who successfully completed the recent Recruitment, Selection, and Recognition Program, attached herein as **Annex "A"**;
- 2. AUTHORIZE the GPPB-TSO to update the List of GPPB Recognized Trainers on the GPPB Website based on validation of compliance by the GPPB Recognized Trainers with the requirements in the MOU; and
- 3. REQUIRE the GPPB-TSO to continue to maintain an updated List of GPPB Recognized Trainers on the GPPB website, to include GPPB-approved new trainers as well as existing trainers who have completed the regular retooling program and maintained their compliance with the requirements in the signed MOU. Additionally, the GPPB-TSO shall submit a report to the GPPB to apprise them on the updated List of GPPB Recognized Trainers.

This Resolution shall take effect immediately.
