SUBJECT: Issuance of Suspension Order to STAD BUILDERS

Pursuant to Sec. 69.1 (i) Rule XXIII of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, and in accordance with Department Order No. 28 series of 2024, this Suspension Order is hereby issued against **STAD BUILDERS**.

Based on the Approved Consolidated Three (3)-Strike Report, dated February 19, 2025, and posted on the DPWH Intranet on February 28, 2025, this contractor, bearing the <u>PhilGEPS</u> <u>Registration No. 201208-57275-1266761380 and located at 20 South Drive Doña Binday</u> <u>Subdivision, Brgy. Malinao, Pasig City, Metro Manila, National Capital Region (NCR)</u>, has incurred three (3) strikes/offenses within a year from the approval date of the Resolution Recommending the Imposition of Strike One - First Warning. While the specific sub-offense categories vary between Implementing Offices (District Engineering Offices) - namely, (i) failure to comply with the required minimum number of key personnel and equipment as stated in the bidding documents, and (ii) submission of an expired Certificate of PhilGEPS Registration (Platinum Membership) - all three (3) violations fall under the main strike offense category of "Submission of Patently Insufficient Bid."

This suspension shall remain in effect during any period of reconsideration or appeal until a final decision is rendered by the Office of the Secretary. However, this suspension does not apply to the contractor's participation in procurement activities of other government agencies.
