**SUBJECT: Issuance of Suspension Order
to E. GARCIA CONSTRUCTION
CORPORATION**

Pursuant to Sec. 69.1 (i) Rule XXIII of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, and in accordance with Department Order No. 28 series of 2024, this Suspension Order is hereby issued against **E. GARCIA CONSTRUCTION CORPORATION**.

Based on the Approved Consolidated Three (3)-Strike Report, dated February 19, 2025, and posted on the DPWH Intranet on February 28, 2025, this contractor, bearing the PhilGEPS Registration No. 201201-46916-83435829 and located at Zone 2 Maharlika Highway Beside Napocor, Naga City, Camarines Sur, Region V, has incurred three (3) strikes/offenses within a year from the approval date of the Resolution Recommending the Imposition of Strike One - First Warning. While the specific sub-offense categories vary between Implementing Offices (District Engineering Offices) - namely, (i) submission of incomplete, insufficient, or defective bid documents with missing mandatory provisions, (ii) failure to submit proof of ownership, lease, purchase agreement of pledged equipment, and (iii) failure to comply with the required minimum number of key personnel and equipment - all three (3) violations fall under the main strike offense category of "Submission of Patently Insufficient Bid."

E. GARCIA CONSTRUCTION CORPORATION is disqualified from participating in any DPWH bidding processes, effective immediately upon receipt of the Notice of Suspension. This



suspension shall remain in effect during any period of reconsideration or appeal until a final decision is rendered by the Office of the Secretary. However, this suspension does not apply to the contractor's participation in procurement activities of other government agencies.

This Order shall take effect immediately.
