**SUBJECT: Amending the Legislative Districts (LDs) of the Component Municipalities of Cavite 1<sup>st</sup> and Cavite 2<sup>nd</sup> District Engineering Offices (DEOs) in accordance with the implementation of Republic Act (R.A.) 11069**

In the interest of the service and pursuant to the implementation of R.A. 11069, the LDs of the component municipalities of Cavite 1<sup>st</sup> and Cavite 2<sup>nd</sup> DEOs in Region IV-A are hereby amended in accordance with the above-mentioned law to ensure consistency with the corresponding Operating Unit in the General Appropriations Act (GAA) and management of data migration in all affected computer applications, as well as paper records for finance and procurement.

Further, by virtue of the aforementioned statute, the municipality of Indang, which is the only town that is under Cavite 2<sup>nd</sup> DEO that is not within the Eighth LD, shall be transferred to the management of Cavite 1<sup>st</sup> DEO.

Cavite 3<sup>rd</sup> District Engineering Office, which was separately created through R.A. 11351 and established by Department Order (D.O.) No. 100, series of 2019, will retain its current set-up since its component municipalities are not affected by the implementation of R.A. 11069.

This Order supersedes D.O. No. 173, s.2015 and other previous issuances in contrary thereto, and to become effective in the Road and Bridge Information Application (RBIA) in FY 2023 in preparation of the succeeding DPWH Infrastructure Program.
