**SUBJECT: Blacklisting for One (1) Year of
 BENJOSH CONSTRUCTION
 SUPPLY**

Pursuant to Section 69.1(i), Rule XXIII of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, and in accordance with Department Order (D.O.) No. 28, series of 2024, this Blacklisting Order is hereby issued to BENJOSH CONSTRUCTION SUPPLY.

Based on the findings and recommendations of the **Bids and Awards Committee (BAC) of the DPWH Camarines Sur 3rd District Engineering Office**, as stated in their Three (3)-Strike Documents dated February 5, 2025, and further consolidated in the Approved Consolidated Three (3)-Strike Report dated May 31, 2025, it has been determined that BENJOSH CONSTRUCTION SUPPLY, with PhilGEPS Registration No. 202207-304260-1261505741, located at Zone 6, Sta Lucia, Magarao, Camarines Sur, Region V, has committed the offense of submission of patently insufficient bid, as determined by the BAC at least three (3) times within a year without valid justifications. These acts tend to defeat the purpose of competitive bidding.

Consequently, considering that the accumulated strikes constitute a set of three (3) similar offenses, the entity is hereby suspended/disqualified from participating in all government procurement activities for a period of one (1) year, starting from 27 JUN 2025 until 26 JUN 2026, pursuant to Item 4.1 of Appendix 17 of the 2026 Revised IRR of R.A. 9184.

The penalty relates to the procurement of the following projects:

As additional measure, the following sanction is also imposed:

1. Forfeiture of Bid Security, which, for violations committed prior to the opening of the financial envelope, is a fixed amount equivalent to two percent (2%) of the Approved Budget for the Contract (ABC). Given the multiple projects involved, the total forfeiture amount is PhP 296,993.31, calculated as 2% of the combined ABC for all three (3) projects listed above.

Furthermore, in accordance with Section 10 of the "Uniform Guidelines for Blacklisting of Manufacturers, Suppliers, Distributors, Contractors and Consultants", as amended by GPPB Resolution No. 14-2020 dated 25 June 2020, the name of the blacklisted entity will be posted in the Consolidated Blacklisting Report (CBR) through the Online Blacklisting Portal within three (3) calendar days from the date of effectivity of this Blacklisting Order. The entity's name will be removed upon the lapse of the penalty period. An accomplished copy of the Government Procurement Policy Board (GPPB) Blacklisting Order Prescribed Form-Appendix 1 is attached for further reference.

This Order shall take effect immediately.
