**SUBJECT: Issuance of Suspension Order to  
NKU CONSTRUCTION & SUPPLY**

Pursuant to Sec. 69.1 (i) Rule XXIII of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, and in accordance with Department Order No. 28 series of 2024, this Suspension Order is hereby issued against **NKU CONSTRUCTION & SUPPLY**.

Based on the Approved Consolidated Strike Report, dated August 31, 2024, and posted on the DPWH Intranet on September 18, 2024, this contractor, bearing the PhilGEPS Registration No. 20190254658180368361 and located at TV Juliano Ave., Purok Zion B, MBRH I, Cotabato City, Maguindanao, ARMM, is found to have committed four (4) strikes/offenses of a similar or identical nature within a year, starting from the approval date of the Resolution Recommending the Imposition of Strike One - First Warning.

This suspension shall remain in effect during any period of reconsideration or appeal until a final decision is rendered by the Office of the Secretary. However, this suspension does not apply to the contractor's participation in procurement activities of other government agencies.

This Order shall take effect immediately.
