SUBJECT: (1) Rectification of Locational Referencing Points (LRPs) along Various Road Sections Under the Jurisdiction of Batangas 1st, Laguna 2nd, and Quezon 3rd District Engineering Offices (DEOs), Region IV-A

(2) Integration of Various Rotundas and Wye Lengths Under the Jurisdiction of Batangas 1st, Cavite 2nd, Cavite 3rd, Laguna 1st, Laguna 2nd, Quezon 3rd, and Rizal 1st DEOs, Region IV-A

In order to maintain the correctness of the Road and Bridge Information Application (RBIA) in accordance with D.O. No. 124, Series of 2016, the rectification, including but not limited to relabeling, installing, and removing of Locational Referencing Points (LRPs) along various road sections under **Batangas 1st, Laguna 2nd, and Quezon 3rd District Engineering Offices (DEOs), Region IV-A** are hereby instituted and implemented in the RBIA, viz:
