SUBJECT: Creation of Technical Working Group (TWG) for the DPWH Alternative Dispute Resolution (DAD-R) Committee

In line with the Department Order (DO) No. 75, series of 2023 and in adherence to the mandatory requirements enumerated under Republic Act (RA) No. 9285, its Implementing Rules and Regulations (IRR), Executive Order Nos. 783 and 974, both series of 2012, and Presidential Decree No. 242, as amended, a Technical Working Group (TWG) is hereby created to be composed of the following:

The said TWG shall have the following functions:

1. Coordinate with the concerned offices and submit a report to the Committee containing the following:
 - a) Certifications of the DPWH process, transactions and/or cases that fall under the Alternative Dispute Resolution (ADR) System.
 - b) Identify and list cases that shall be governed by the ADR with the corresponding legal basis.
 - c) Prepare an ADR System Process Flow Chart including a recommendation on appealed cases to the Secretary, to be approved by the Committee.
2. Considering the ADR System Process Model, harmonize the same with the existing Department process/procedure with the proposed DPWH ADR.
3. Convene, as necessary, in order to serve the purpose of this Special Order (SO).
4. Analyze and examine the compliance by the DPWH in every ADR System to be presented to the Committee.
5. Assist the Capacity Development Division (CDD), HRAS, to coordinate with the Office of the Alternative Dispute Resolution (OADR), Department of Justice (DOJ) on the trainings to be conducted and engaged by the Committee Members, TWG and DPWH personnel.
6. Such other tasks as may be assigned by the Committee.

This Order shall take effect immediately.
