## Bureau of Design

- Shall be responsible for the technical review of the Agency Estimate (POW & ABC), PERT/CPM Bar Chart carried out in accordance to standards and guidelines set forth by the Department and shall see to it that these are facilitated for its timely approval, inclusive of time suspension/extensions, applied variation orders, and other project documents relative thereto as may be needed from time to time.

## Bureau of Research and Standards

- Shall be responsible for the necessary review/evaluation of new pay items introduced for the satisfactory completion of the project and facilitate timely approval of same.

## Procurement Service

- Shall be responsible for the timely conduct of Bidding Processes in accordance to guidelines and proceedings set by the Department.
