SUBJECT: DPWH Committee for the Creation of the PAGCOR - Funded Infrastructure Projects Guidelines

The Philippine Amusement and Gaming Corporation (PAGCOR), a government-and controlled corporation (GOCC) created and existing under the Presidential Decree (PD) No. 1869, s.1983 as amended, mandated to generate revenues for the country's socio-economic, infrastructure and national development programs, is willing to entrust public funds to national government agencies and qualified institutions to aid the delivery of public service for development programs, education and/or social welfare. In this line, PAGCOR has allocated funds for the construction of the following infrastructure projects to aid in the government's nation-building agenda:

PAGCOR Infrastructure Project for the Construction of:	PURPOSE
DEPED SCHOOL BUILDING PROJECT	help address the acute deficiency of classrooms nationwide
SOCIO-CIVIC CENTER	provide a multi-purpose building for the delivery of essential services to the constituents
E-LEARNING CENTER	provide access to a broader range of information via internet
COMMUNITY WELLNESS CENTER	to provide basic evaluation and address the basic health care needs and requirements of the community

To achieve this purpose, the PAGCOR, using the said revenues, shall transfer funds to the DPWH intended for the construction of the above-mentioned programs.

In this regard, the PAGCOR sought the aid of the DPWH, being the engineering and construction arm of the government, to serve as the Implementing Agency (IA) to achieve the purpose of these PAGCOR Projects.

In this regard, the guidelines shall guide the DPWH and PAGCOR, with the beneficiary government agency (DepEd or LGU) as parties in entering into a Memorandum of Agreement. In order establish the duties and responsibilities of the parties the DPWH Committee shall craft this guideline of the implementation of FY 2024 PAGCOR-Funded infrastructure projects.

Therefore, the undersigned hereby established the **DPWH Committee for the Creation of 2024 PAGCOR-Funded Infrastructure Projects Guidelines**.

## I. PRIMARY FUNCTIONS:

The Committee shall have the following duties and responsibilities:

1. Represent the DPWH in the issuance of the Joint Circular Memorandum between Department of Public Works and Highways (DPWH), Philippine Amusement and Gaming Corporation (PAGCOR);

2. Craft, contribute, issue and implement the said guidelines;

- 3. Draft, craft and formulate the appropriate templates, provided by PAGCOR, for the Memorandum of Agreement (MOA) between DPWH Implementing Office Head, PAGCOR, and other appropriate government agency-beneficiaries;
- 4. Discuss matters related to the past issues concerning the PAGCOR-Funded Projects and harmonize the same with the guidelines;
- 5. Recommend, for the approval of the undersigned this Guidelines; and
- 6. Upon the issuance of the Guidelines, recommend to the undersigned the resolutions on the issues and concerns that may be encountered in the future.
