SUBJECT: Creation of an Inter-Agency Steering

Committee for the DPWH Tree **Planting Convergence Initiative with**

the DENR

In line with the policy direction of the Department of Public Works and Highways (DPWH) to attain environmental sustainability and biodiversity conservation and enhance climate change mitigation and adaptation for economic growth and stability, an Inter-Agency Steering Committee (IASC) composed of representatives from the DPWH and the Department of Environment and Natural Resources (DENR) is hereby created to ensure the effective and coordinated planning and implementation of the DPWH Tree Planting Convergence Initiative with the DENR in line with the Memorandum of Understanding between the DPWH and DENR.

The IASC shall ensure the successful accomplishment of the objectives of the Tree Planting Convergence Initiative including, but not limited to, providing policy guidelines and overseeing the implementation of the DPWH-DENR Memorandum of Understanding.

Lastly, a Technical Working Group (TWG) shall likewise be created to assist the IASC in developing plans for the maintenance, protection and conservation of trees planted pursuant to this undertaking, monitoring of tree planting activities, and such other functions which may be assigned by the IASC for the accomplishment of the objectives of this convergence initiative.

The TWG shall be headed by **Project Manager ROSEMARIE B. DEL ROSARIO, DSD.**, Division Chief, Environmental and Social Safeguards Division, Planning Service, with its composition/members to be selected and determined under a separate Special Order.

This Order shall take effect immediately.
