The committee members shall undertake the procurement process strictly in accordance with the rules, regulations and guidelines applicable thereto.

Regular members of the BAC, who shall be on a "jury duty" type of assignment until the Notice of Award is issued by the Head of the Procuring Entity, shall have a fixed term of one (1) year reckoned from the date of appointment, renewable at the discretion of the Secretary. In case of resignation, retirement, separation, transfer, reassignment, removal or death, the replacement shall serve only for the duration of the unexpired term.

The term "jury duty" shall be understood to mean a state by which the members give utmost priority to BAC assignment over all the other duties and responsibilities until the requirements for the said assignments at-hand are completed.

RECONSTITUTION OF THE CENTRAL OFFICE BIDS AND AWARDS COMMITTEE (BAC) FOR CONSULTING SERVICES

The Procurement Service, which shall serve as the BAC Secretariat, shall assist the BAC. The Technical Working Group (TWG), which shall be organized by the Committee Chairperson, shall perform functions as directed.

This Special Order shall supersede S.O No. 170, Series of 2023, and shall take effect immediately.
