- 3. Provide assistance to the Consultant in the coordination and consultations among stakeholders and local government units in the preparation of indicative relocation/resettlement action plan;
- Provide guidance and resolve issues/constraints that may arise during the course of the design and construction;
- 5. Monitor the progress of the design and construction;
- 6. Evaluate the accomplishment of the targets and achievements of the objectives;
- 7. Review and evaluate the results and recommendations of the Consultant;
- 8. Ensure success and desired outcome of the project implementation.

The Steering Committee may invite other DPWH officials/personnel, concerned agencies and entities to participate and/or provide assistance in the implementation of the project, as the need arise.

This order supersedes Special Order No. 58, series of 2023, and shall take effect immediately until the completion of the project.
