The Southeast Metro Manila **Expressway** (SEMME/C6) Project is a toll road project with approximately 32.664 km. in length. The expressway has a combination of elevated and at- grade and mostly six lanes with two directional traffic flows. It will connect from the existing skyway at FTI in Taguig City, run along C5/Diego Silang towards existing C6 in Taguig City, continue along Laguna Lake, then link to Ortigas Avenue extension, cross Sumulong Highway, towards Marcos Highway to Tumana Bridge at San Mateo, Rizal and terminate to Batasan Complex at Quezon City.
