### **PROJECT OBJECTIVES:**

- Reduce travel time from Tarlac City to Gerona from 45 minutes to 10 minutes, 8,000 vehicles per day will be benefited.
- Reduce travel time from Tarlac City to Paniqui, Tarlac from 1 hour to 15 minutes, 10,000 vehicles per day will be benefited.
- Reduce travel time from Tarlac City to Rosales from 2 hoursto 30 min., 13,000 vehicles per day will be benefited.
- Reduce travel time from Tarlac City to Urdaneta from 2 hours and 30 minutes to 40 minutes.
- Reduce travel time from Tarlac City to Rosario from 3.5 hours to 1 hour, 20,000 vehicles per day will be benefited.
