25AH0197 Provision of Tree cutting along Pangasinan - Zambales Road and Pangasinan - Tarlac Road within the Municipality of, Bugallon, Pangasinan

1. The DPWH Pangasinan 2nd District Engineering Office, through the **GAA 2024** intends to apply the sum of **Php 3,005,900.00** being the Approved Budget for the Contract (ABC) to payments under the contract for **25AH0197 Provision of Tree cutting along Pangasinan - Zambales Road and Pangasinan - Tarlac Road within the Municipality of, Bugallon, Pangasinan**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The DPWH Pangasinan 2nd District Engineering Office through its Bids and Awards Committee now invites bids for the hereunder Works:

To be eligible to bid for this Contract, a contractor must meet the following major requirements: (a) Filipino citizen or 75% Filipino-owned partnership/corporation with PCAB license for Size Range **Small B**, (b) completion of a similar contract costing at least 50% of the ABC, and (c) Net Financial Contracting Capacity (NFCC) at least equal to the ABC. The description of an eligible Bidder is contained in the Bidding Documents, particularly, in Annex II-1.1 B Section II and III of Bidding Documents.

Contractors/applicants who wish to participate in this bidding are encouraged to enroll in the DPWH Civil Works Application (CWA) at the DPWH Procurement Service (PrS), 5th Floor, DPWH Bldg., Bonifacio Drive, Port Area, Manila, while those already enrolled shall keep their records current and updated. The Contractor's eligibility to bid on the project will be determined using the DPWH Contractor Profile Eligibility Process (CPEP) and subject to further post-qualification. Information on registration can be obtained from the PrS during working weekdays from 7:00 am to 4:00 pm or at the DPWH website www.dpwh.gov.ph.

4. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". The contract shall be awarded to the Lowest Calculated Responsive Bidder (LCRB) who was determined as such during post-qualification.
5. Interested bidders may obtain further information from the **DPWH Pangasinan 2nd District Engineering Office** and inspect the Bidding Documents at **Alvear St., Lingayen, Pangasinan** during weekdays from **8:00 A.M. – 5:00 P.M.**
6. A complete set of Bidding Documents may be acquired by interested bidders on **July 21, 2025 to August 12, 2025** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php 5,000.00**.

7. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
8. The DPWH Pangasinan 2nd District Engineering Office will hold a **Pre-Bid Conference** on **July 29, 2025, 10:00 AM** at **Conference Room, DPWH Pangasinan 2nd District Engineering Office, Alvear St., Lingayen, Pangasinan**, which shall be open to prospective bidders.
9. Bid submission maybe done manually or electronically/online. However, bidders should only select one (1) mode of submission, either manual or electronic. Similar to manual submission, the guidelines for the preparation and submission of an electronic bid are contained in the **BDS**.
10. Bids must be duly received by the BAC Secretariat at the address below for manual submission or at **electronicbids_pangasinan2@dpwh.gov.ph** for electronic submission on or before **August 12, 2025, 9:00 A.M.**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.
11. Bid opening shall be on **August 12, 2025, 9:00 A.M.** at **Conference Room, DPWH Pangasinan 2nd District Engineering Office, Alvear St., Lingayen, Pangasinan**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
12. The **DPWH Pangasinan 2nd District Engineering Office** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
