Prospective Bidders should be (1) registered with and classified by the Philippine Contractors Accreditation Board (PCAB) with PCAB LICENSE Category for License Classification as stated above for each project. The description of an eligible Bidder is contained in the Bidding Documents, particularly, in Annex 11-1.1B Section II and III of Bidding Documents.

Contractors/applicants who wish to participate in this bidding are encouraged to enroll in the DPWH Civil Works Application (CWA) at the DPWH Procurement Service (PrS), 5<sup>th</sup> Floor, DPWH Bldg. Bonifacio Drive, Port Are, Manila, while those already enrolled shall keep their records current and updated. The contractor's eligibility to bid on the project will be determined using the DPWH Contractor Profile Eligibility Process (CPEP) and subject to further post-qualification. Information on registration can be obtained from the PrS during working weekdays from 7:00 am to 4:00 pm or at the DPWH website [www.dpwh.gov.ph](http://www.dpwh.gov.ph).

4. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". The contract shall be awarded to the Lowest Calculated Responsive Bidder (LCRB) who was determined as such during post qualification.
5. Interest bidders may obtain further information from the Department of Public Works and Highways, Samar Second District Engineering Office, Brgy. Guindapunan, Catbalogan City, Samar and inspect the Bidding Documents at Department of Public Works and Highways, Samar Second District Engineering Office, Brgy. Guindapunan, Catbalogan City during weekdays from **8:00 A.M. – 5:00 P.M.**



6. A complete set of Bidding Documents may be acquired by interested bidders on **August 2, 2025** to **August 22, 2025** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount stated above.
7. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
8. The Department of Public Works and Highways, Samar 2<sup>nd</sup> District Engineering Office, Brgy. Guindapunan, Catbalogan City, Samar will hold a Pre-Bid Conference on 10:00 AM of **August 8, 2025** at Conference Room, DPWH, Samar 2<sup>nd</sup> DEO, Catbalogan City, Samar, which shall be open to prospective bidders.
9. Bid submission maybe done manually or electronically/online. However, bidders should only select one mode of submission, either manual or electronic. Similar to manual submission, the guidelines for the preparation and submission of an electronic bid are contained in the **BDs**.
10. Bids must be duly received by the BAC Secretariat at the address below for manual submission or at [electronicbids\\_samar2@dpwh.gov.ph](mailto:electronicbids_samar2@dpwh.gov.ph) for electronic submission on or before 10:00 AM of **August 22, 2025**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.
11. Bid opening shall immediately be done after dropping of bid documents on **August 22, 2025** at Coference Room, DPWH, Samar 2<sup>nd</sup> DEO, Catbalogan City, Samar. Bids will be opened in the presence of the bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.
12. The Department of Public Works and Highways, Samar 2<sup>nd</sup> District Engineering Office, Brgy. Guindapunan, Catbalogan City, Samar reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract award in accordance with Section 41 of RA 9184 and its IRR.
