In consideration for the sum of **(Nine Million Eight Hundred Forty Nine Thousand Seven Hundred Thirty Pesos and Fifty Six Centavos Only (Php 9,849,730.56))** or such other sum as may be ascertained, **(CATARMAN BUILDERS CONSTRUCTION)** agrees to **(Concreting of Brgy. San Isidro to Brgy. San Juan FMR, Brgy. San Isidro and Brgy. San Juan, Lavezares, Northern Samar)** in accordance with his/her/its Bid. The **Department of Public Works and Highways (DPWH)** agrees to pay the above-mentioned sum in the day and year first before written.

A slippage of more than thirty (30) days in the original schedule would result in non-payment, the cancellation of the contract, blacklisting of the erring contractor, and the entry of a new contractor who will finish the project.
