
- a.) To declare **Yenz Construction** as the Bidder with the Single Calculated Responsive Bid (SCRB) for the abovementioned Contract;

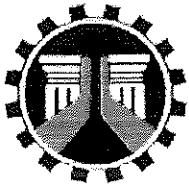
