Should such review uncover any misinterpretation made in the eligibility requirements, statements or documents, or any changes in the situation of the bidder which will affect the capability of the bidder to undertake the project so that it fails the eligibility criteria, the Procuring Entity shall consider the said bidder as ineligible and shall disqualify it from obtaining an award or contract, in accordance with Rules XXI, XXII, and XXIII of this IRR."

NOW THEREFORE, we the members of the Bids and Awards Committee, hereby RESOLVE as it if hereby RESOLVED:

- a.) To declare **Centerways Construction & Development, Inc.** as the Bidder with the Lowest Calculated Responsive Bid (LCRB) for the abovementioned Contract;
