**WHEREAS**, the **DPWH Quezon 1<sup>st</sup> District Engineering Office, Lucban, Quezon**, advertised the invitation to bid for the above-mentioned Contract IDs and posted the same at the DPWH Website, the PhilGEPS and at a conspicuous place at the premises of the District Office continuously for seven days on May 30, 2025 to June 06, 2025;
