**BAC RESOLUTION DECLARING THE BIDDER WITH THE SINGLE CALCULATED  
RESPONSIVE BID AND RECOMMENDING AWARD THERETO**

**WHEREAS**, the DPWH-Cagayan 3<sup>rd</sup> District Engineering Office advertised/posted the Invitation to Bid for the above-stated project on February 28, 2025 at the DPWH and PhilGEPS website and at a conspicuous place within the premises of the DPWH-CTDEO for seven (7) calendar days;

**WHEREAS**, in response to the said Invitation, two (2) interested bidders purchased bidding documents from February 28, 2025 until the deadline for the submission of bids, to wit:

1. KNI88 HARDWARE AND CONSTRUCTION SUPPLY
2. MAIDA'S CONSTRUCTION

**WHEREAS**, the prospective bidders, KNI88 HARDWARE AND CONSTRUCTION SUPPLY and MAIDA'S CONSTRUCTION, submitted their respective bids on March 20, 2025 on the prescribed place and time;

**WHEREAS**, during the Bid Opening, the BAC through the Secretariat read the generated result of Contractor's Electronic Eligibility screening using the DPWH Civil Works Application (CWA) to check the bidders' compliance as to legal, financial, and technical capabilities, simultaneously, preliminary examination was conducted on the technical envelopes of the two (2) bidders, using a non-discretionary "pass/fail" criterion (presence or absence of required documents) against the checklist of requirements as stipulated in the bidding documents;

**WHEREAS**, the BAC found out that KNI88 HARDWARE AND CONSTRUCTION SUPPLY passed the preliminary examination and proceeded with the opening of its financial bid, while MAIDA'S CONSTRUCTION was declared "*Ineligible*" and "*FAILED*", due to expired attached PhilGEPS Registration Certificate in the submitted technical proposal. **WHEREAS**, after the opening and preliminary evaluation of bids, the BAC informed the bidders that their bids shall be subjected to bid evaluation and post qualification as required in the 2016 Revised IRR of R.A. 9184;

**WHEREAS**, the BAC forwarded certified true copies of updated NFCC for 4MD JSL CONSTRUCTION INC., stamped "Received" by the Bureau of Internal Revenue (BIR) on its Audited Financial Statements, including PhilGEPS Registration Certificate, to the Procurement Service, DPWH-Central Office for updating, and a Request for Unlocking at CWA, in order for the BAC to re-process the eligibilities of the said bidder;

**WHEREAS**, the BAC, with the assistance of its Technical Working Group, conducted the detailed evaluation of the above-mentioned bids on March 21, 2025 which resulted in the following bid as calculated:

**WHEREAS**, after the bid evaluation conducted by the TWG and as presented to the BAC, the result showed that 4MD JSL CONSTRUCTION INC. was found compliant to the requirements of the financial envelope, hence, recommended as complying;

**WHEREAS**, on March 27, 2025, the BAC received the approval of the request for unlocking thru email (outlook). The BAC thru the BAC-Secretariat conducted the re-processing of the eligibility check for 4MD JSL CONSTRUCTION INC. wherein it was found eligible;

**WHEREAS**, the TWG completed the post-qualification to the Single Calculated Responsive Bidder, **4MD JSL CONSTRUCTION INC** on March 28, 2025. Result showed that the bidder has satisfied the legal, technical and financial requirements of the Bidding Documents, hence, the BAC found its bid responsive and, therefore, the bidder is **post-qualified**;

**NOW, THEREFORE**, we, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- To declare **4MD JSL CONSTRUCTION INC.**, the Bidder with the Single Calculated Responsive Bid (SCRB) for the above Contract; and
- To recommend to the **District Engineer** for approval the award of the said Contract to **4MD JSL CONSTRUCTION INC.** the Single Calculated Responsive Bid (SCRB) at its total submitted bid or total Calculated Bid, whichever is lower, in the amount of **FOUR MILLION NINE HUNDRED TWENTY FOUR THOUSAND NINE HUNDRED EIGHTY THREE PESOS AND 19/100 (P4,924,983.19).**
