WHEREAS, the DPWH-Cagayan 3rd District Engineering Office advertised/posted the Invitation to Bid for the above-stated project on May 14, 2025 at the DPWH and PhilGEPS website and at a conspicuous place within the premises of the DPWH-CTDEO for seven (7) calendar days;

WHEREAS, in response to the said Invitation, only one (1) interested bidder purchased bidding documents from May 14, 2025 until the deadline for the submission of bids, to wit:

WHEREAS, the bidder submitted its respective bid on June 02, 2025 on the prescribed place and time;

WHEREAS, during the Bid Opening, the BAC through the Technical Working Group (TWG) read the generated result of Contractor's Electronic Eligibility screening using the DPWH Civil Works Application (CWA) to check the bidders' compliance as to legal, financial, and technical capabilities, simultaneously, preliminary examination was conducted on the technical envelope of the lone bidder, using a non-discretionary "pass/fail" criterion (presence or absence of required documents) against the checklist of requirements as stipulated in the bidding documents;

WHEREAS, the BAC, with the assistance of its Technical Working Group, conducted the detailed evaluation of the above-mentioned bid on June 04, 2025 which resulted in the following bid as calculated:

WHEREAS, after the bid evaluation conducted by the TWG and as presented to the BAC, the result showed that JVC CONSTRUCTION was found compliant to the requirements of the financial envelope, hence, recommended as complying;

WHEREAS, the TWG completed the post-qualification to the Single Calculated Responsive Bidder, **JVC CONSTRUCTION** on June 13, 2025. Result showed that the bidder has satisfied the legal, technical and financial requirements of the Bidding Documents, hence, the BAC found its bid responsive and, therefore, the bidder is **post-qualified**;


